- The following standard conditions shall apply to this Open Burning Permit upon issuance by the Township:
1. This Open Burning Permit may only be issued for the exceptions listed under Section 377-14.
 2. The open burning area must be setback at least 50 feet from any building, structure or combustible materials.
 3. The open burning areas must be setback at least 25 feet from any public street or right-of-way.
 4. There must always be at least one responsible adult (18 years or older) attending the open burning area until the fire is extinguished.
 5. It is the Applicant's responsibility to notify the Berwyn Fire Company and Paoli Fire Company prior to the open burning.
 6. The time, location, and date approved in this Open Burning Permit must be strictly adhered to.
