1. This permit may only be issued for entertainment purposes.
 2. Property Owner and Pyrotechnics Vendor must provide Certificates of Insurance naming Easttown Township as Additional Insured in the minimum amount of \$5,000,000.00.
 3. It is the Applicant's responsibility to notify local fire companies prior to the event as appropriate to the location of the property on which the bonfire is to occur, including Berwyn Fire Company and/or Paoli Fire Company and receive written approval for the appropriate Fire Chief. This approval must be submitted to the Township prior to issuance of a permit.
 4. The time, location, and date approved in this permit for the fireworks display must be strictly adhered to. Please notify and request permission from the Township prior to rescheduling.
